It aims to integrate significant theory and research results with practical skills and personal introspection by the students.</p> <p>The approach of the course is to engage students in discussions and exercises that explore the relationship between theories and practices of nonprofit decision making and leadership.</p> <p>The overall goal of the course is to provide a framework within which students of the class can actually practice decision making and leadership skills in as realistic and practical a way as is possible within the confines of a class situation. By the end of the course, students should:</p> <p>1.Understand the nature of decision making and leadership;</p> <p>2.Understand the factors with which nonprofit leaders have to cope;</p> <p>3.Be able to analyze complex case situations and suggest possible ways of dealing with them;</p> <p>4.Perceive an improvement in their personal leadership and decision making skills.</p> <p>The objectives of this course include:</p> <p>1.Developing a common language and understanding of decision making and leadership;</p> <p>2.Defining characteristics and traits of leadership;</p>
