There are total 1,225 articles in our Civil law, classified into 5 chapters: general principles, liabilities, substance rights, relatives, and inheritance act.(1)General principles of Civil Law: The principle rules of Civil Law, total 152 articles in 7 sections.(2)Liabilities of Civil Law: General rules and classified rules of liability. Amended on April 21st, 1999, and practiced on May 5th, 2000.(3)Substance rights of Civil Law:Total 210 articles in 10 sections. Regulations of ownership and hypothec.(4)Relative rights of Civil Law:Total 7 sections. Amended 6 times. Regulations of marriage, property of married couple system, and divorcement.(5)Inheritance act of Civil Law: Total 3 sections, amended on June 3rd, 1985. Regulations of inheritors, inheritance allotments and wills.
